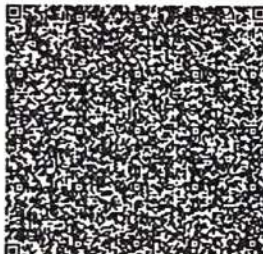


AND WHEREAS, pursuant to the above, both the parties wish to record hereunder the terms and conditions of the agreement entered into between them for the Software support by the COMPANY of the requisite software for the Examinations Management System and for maintenance of the same to the COLLEGE.

NOW, THEREFORE, THIS AGREEMENT WITNESSTH AND THE PARTIES HERETO RECORD HEREUNDER THE SAID TERMS AND CONDITIONS

1. The project shall be for a period of three year duration – effective from 01.04.2017 to 31.03.2020.
2. For the first year of the project, composite sum of Rs. 1,10,000/- (Rupees one lakh ten thousand only) and applicable taxes shall be paid by the COLLEGE to the COMPANY in the manner provided hereunder, the company has undertaken to maintain the Examination Management System software comprising of the work more fully described in the SCHEDULE A hereunder
3. For the second year of the project, composite sum of Rs. 1,21,000/- (Rupees one lakh twenty one thousand only) and applicable taxes shall be paid by the COLLEGE to the COMPANY in the manner provided hereunder, the company has undertaken to maintain the Examination Management System software comprising of the work more fully described in the SCHEDULE A hereunder
4. For the third year of the project, composite sum of Rs. 1,33,100/- (Rupees one lakh thirty three thousand one hundred only) and applicable taxes shall be paid by the COLLEGE to the COMPANY in the manner provided hereunder, the company has undertaken to maintain the Examination Management System software comprising of the work more fully described in the SCHEDULE A hereunder






- d. Support shall be provided from Bangalore through Internet
  - e. Cease to take any responsibility regarding the development / support after the maintenance period, except for continued confidentiality of the software developed already.
5. The COMPANY shall pay as penalty an amount 25% of the cost agreed upon, in case any default or damages are caused in the maintenance of accuracy, confidentiality and time schedule in the process of development and application of the said software.
  6. The COLLEGE is not authorized to replicate the software covered under this agreement at any other University / College / location
  7. **Software modification to be carried out based on the request of the COLLEGE that includes new reports / modification of existing reports, design of new marks card format, modifying exiting marks card format shall be charged separately and does not form the scope of this contract**
  8. Payment terms and conditions :
    - a) 50% of the consideration for each year shall be paid by the COLLEGE to the COMPANY on or before 30<sup>th</sup> April of every year
    - b) 50% of the consideration for each year shall be paid by the COLLEGE to the COMPANY on or before 31<sup>st</sup> October of every year
    - c) When the COMPANY officials visit the COLLEGE, they shall be paid an amount of Rs. 5,000/- for the first day and Rs. 3,000/- from the second day and onwards
  9. The parties to the Agreement shall settle any dispute arising with regard to interpretation or implementation of this Agreement, through mutual consultations and agreements. In case settlement is not arrived at, the decision of Principal of the COLLEGE shall be binding on the parties to this agreement.
  10. This agreement is subject to the jurisdiction of the courts at Mysuru / Bengaluru.
